TUITION CONTINUED

TECHNOLOGY FEE - This \$300 technology fee will cover the costs associated with the rental of a school-owned Chrome Book, wireless internet and other technological devices, all of which will better assist cadets in the classroom.

RETURNING CADET DISCOUNT - A second year cadet will receive a \$500 discount, a third year cadet will receive an \$800 discount and a fourth year cadet will receive a \$1,000 discount. However, these discounts are only available if the cadet is continuously enrolled year after year.

TUITION DISCOUNTS - Active Duty/Retired Military 10%; First Responder \$1,000; Minister \$1,000; Single Parent 10%; Siblings 25%; and Airline Employee 10%.

TUITION - This fee covers instruction, room, and board. It does not include spending money, special medical care beyond the facilities of the infirmary, driver's education, flying lessons or willful destruction of property. Parents are billed on a monthly basis for extra charges incurred.

FINANCIAL OBLIGATION - The cost of operating the Academy must be budgeted on an annual basis. For this reason, cadets are accepted the entire school year, and upon entrance a valid and binding contract is in force for the entire school year.

Additionally, because the Academy's budget is tuition-driven, payments are required in a timely fashion. Any payment not received in the Academy's business office or through FACTS by the date due will be assessed a \$30.00 late charge. As stated in the contract, should any amount become delinquent, grades and transcripts will be held until the account is settled. Delinquent accounts may be forwarded to an outside agency for collection. Failure to make payments by the due date may result in a cadet's separation.
